



## Invitation for Bids

1. The Government of Mongolia has received financing from the Asian Development Bank (ADB) toward the cost of **Sustaining Access to and Quality of Education During Economic Difficulties Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Ministry of Education and Science** (“the Employer”) invites sealed bids from eligible Bidders for the **School and Kindergarten Furniture and Equipment** (“the Goods”), wherein the bids are invited for the procurement of the following 7 lots.
